Dear FEC Termination Committee:

Enclosed is our Debt Settlement Plan and Termination Report for Todd Akin for Senate (C00343475), along with a revised FEC Form 1 Statement of Organization, 2014 April Quarterly Amend Report (Q1), and 2013 YE 2nd Amend Report. There are several items that need a word of explanation.

- 1) We had several contributions that were over the biennial limits. The recent Supreme Court decision has resolved that issue.
- 2) There were a few people who over contributed from more than a year ago. We sent refund checks at the time of the over contributions, which to date remain uncashed. We have sent several letters to these contributors to no avail. The two who did respond to our communications, have been refunded.
- 3) Congressman Todd Akin has loaned the Campaign Committee \$10,000.00 to cover the final expenses. When the books are closed, the Campaign will reimburse any remaining funds in the account to Congressman Akin against that loan. In addition, there will be a few small checks from the rental of a mailing list. These residual funds will go towards the balance of Congressman Akin's loan, but may not fully repay it. Any remaining balance of Mr. Akin's loan will be forgiven.
- 4) We have had some difficulty with our Aristotle software accurately aggregating our situation.
- 5) Lastly we wish to call your attention to the tremendous professional assistance that we have received from Nataliya Ioffe and her staff. They have cheerfully answered a great number of inquiries quickly and courteously.
