
Dear Mr. Ciaraldi:

Thank you for your call yesterday informing me of the outstanding issues before the Commission regarding the 2000 Republican House-Senate Dinner Committee. As I told you, it is of the highest importance to me to fully comply with all regulations set by the Commission as well as to maintain a complete and accurate public record. Had I been aware of these requests, I would certainly have answered them promptly. Currently, the bulk of the mail for the committee is sent to the street address, however the Commission uses the official post office box address which, apparently, no one had been checking. The vast majority of the committee's activity ended several months ago, as you can see in our latest filings. In fact, the committee is preparing to file the year-end report as a request for termination. It is clear to me now, that I should have changed the committee's address in order to avoid such a situation, however, this had never happened to me before in the ten years that I have been filing reports with the Commission. You will please note that I have included an amended Form 1 to change the address.

- An amended schedule H4 has been provided to clarify the description "Consultant Fees".
- The "petty cash" description shown on schedule H4 (3/15/00) for \$200.00 was for the entire petty cash fund of the committee for the year pursuant to 11 CFR 102.11. All disbursements from this fund were under the \$100 limit. I have attached the log that currently shows a balance of \$6.83 in the petty cash fund. I have also maintained the addresses for all of those receiving petty cash.
