Mr. Chester took status as a retired partner of Covington & Burling LLP on October 1, 2011. He subsequently notified Covington and Burling LLP PAC that he was terminating his automatic payroll deduction for contributions to the PAC, and requested that the change be made retroactive to his change in status. The PAC agreed and reimbursed Mr. Chester for contributions he made via payroll deduction from 10/03/2011 to 12/3/2012.
