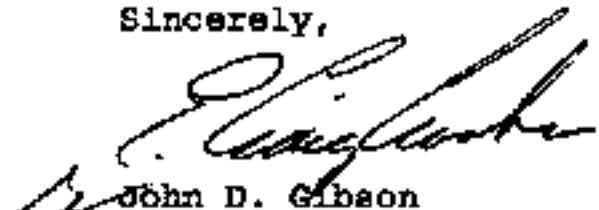
Dear Mr. Tarnok:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Pursuant to 11 CFR §110.6(c) all earmarked contributions, that have passed through a conduit's account, must be itemized on the receipt and disbursement schedules. Your report disclosed the receipt of earmarked contributions on Schedule A, but does not include any corresponding itemized disbursements on Schedule B. All earmarked contributions must be forwarded to the recipient candidate committee within 10 days of receiving the contribution. §102.8(a) and (c) Please amend your report by providing the omitted disbursement schedules for all earmarked contributions disclosed by your committee.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
