With regard to the amended Pre-General report, the most up-to-date ending cash on hand balance from the previous monthly report was not used as the beginning cash on hand. This caused the calculation error on Line 8. The correct beginning cash on hand balance is now being used and the Line 8 calculation has been corrected. In addition, we have disclosed an itemized bank fee on Line 21(b) that had been inadvertently undisclosed. We have also disclosed a \$5,000 disbursement to the Maryland Democratic Party (Federal Account) that had been inadvertently undisclosed.
