Upon the reorganization of Tenneco Inc. into two separate, publicly-traded companies and with the recommendation of the Chairman of Operating Committee of the Tenneco Employees Good Government Fund ("TEGGF"), I hereby direct that the TEGGF be dissolved.

Pursuant to Article IV of the TEGGF Amended Charter (1997), I direct that readily identifiable undistributed funds be returned to contributors on a last contributed, first returned basis and that all documents necessary to effect the dissolution be filed as may be required by law or regulation.
