After an internal audit going back to Dec 2011 and after consultation with the Reports Analysis Division of the FEC the PAC is reporting an adjustment on Sch A Line 17 for 260.00 to correct the PACs cash on hand total to bring it into alignment with the PACs bank balance. The adjustment is believed to be linked to historical transactions, and the adequacy of payroll file data uploads or clerical errors related to calculations for bank deposits. The PAC has made adjustments to its management by hiring a new vendor to assist with PAC operations and FEC report preparation. The PAC has also reviewed its internal operating policies with key personnel, and has upgraded its internal processes for data management to include secure, electronic data transfer. Going forward, the PAC expects that with these changes, it is unlikely such adjustment as that found in this report will be necessary. Amendment also reflects a correction to the Column B totals due to the amendment of the m6 report.
