Dear Mr. Turner:

On November 25, 1996, you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.

Your December 7, 1996 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.

Schedule A of your report discloses a contribution(s) which appears to exceed the limits set forth in the Act (copies attached). You should conduct a review of all of your contributions to determine the rest of the excessives that your committee may have received. As you check for additional excessives, you should review the committee's procedures for handling the receipt of contributions.

Your response states that redesignations for contributions from individuals were requested on December 5, 1996. You still need to provide evidence (i.e., copy of signed redesignation letter) of redesignation and memo Schedules A to report the corrective action (as noted below). In addition, please clarify the action taken by your committee to correct excessives received from affiliated committees (NATCA PAC, NMU PLOW & MEBA PAF).

If the contribution(s) in question was not completely or correctly reported, you should amend your original report using the new or corrected information. If the contribution(s) exceeds the limits, you should either

refund to the donor the amount in excess of \$1,000 or get the donor to redesignate and/or reattribute the excessive amount in writing. All refunds, redesignations, and reattributions must be made within sixty days of receipt of the contribution. Copies of refund checks and copies of letters reattributing or redesignating the contributions in question may be used to respond to this letter. Refunds are reported on Line 20 of the Detailed Summary Page and on a supporting Schedule B of the report covering the period in which they are made. Redesignations and reattributions are reported as memo entries on Schedule A of the report covering the period in which the authorization for the redesignation and/or reatribution is received. (11 CFR §104.8(d)(2), (3) and (4))

The acceptance of excessive contributions is a serious problem. Again, the committee's procedures for processing contributions should be examined and corrected in order to avoid this problem. Although the Commission may take further legal action, prompt action by you to refund or seek redesignation and/or reatribution of the excessive amount will be considered.

-Your report discloses contribution(s) from a corporation and labor organization (pertinent portion attached). A contribution from a corporation and labor organization is prohibited by the Act, unless it is made from a separate segregated fund established by the corporation and labor organization. (2 U.S.C. §441b(a) and 11 CFR §103.3(b))

Your 30 Day Post-General Report (10/17/96-11/25/96), filed on December 5, 1996, disclosed refunds to correct the prohibited contributions received from Emerald Society FDNY and AFGE Local 2693. You still need to clarify the corrective action taken to address the prohibited contributions received from Iron Workers Local 40 and Oxford Truck Leasing.

If the contribution(s) in question was not completely or correctly reported, you should amend your original report with the corrected information. If the contribution is from a corporation and labor organization, you should refund the full amount to the donor and notify the Commission of such action. The refund must be made within thirty days of the treasurer becoming aware of the impermissibility of the contribution. (11 CFR §103.3(b)(2)) Copies of refund checks for the contribution(s) in question may be used to respond to this letter. The refund should be reported on a Schedule B supporting Line 20(a) of the report covering the period in which the refund is made. (11 CFR §104.8(d)(4))


