Dear Sirs;

This letter is in response to your July 11, 2008 inquiry regarding Every Republican Is Crucial's (ERIC PAC's) 2008 June Monthly Report.

In response to the two inquiries regarding ERIC PAC's 5/6/08 contribution of \$5,000 to Greg Davis for Congress, the contribution should have been listed on our report as a contribution to retire debt from the primary election, not the special primary election. The contribution check was properly designated to retire primary debt, but a transcription error was made when reporting the contribution on ERIC PAC's 2008 June Monthly Report. Accordingly, we have amended the report to show that the contribution was to retire primary debt, not debt incurred from a special primary election.

Enclosed are copies of correspondence from the Treasurer of Greg Davis for Congress and return correspondence from me confirming that the campaign had \$15,000 in net-debts outstanding from the primary election (which have also been disclosed on Schedule C of the Greg Davis for Congress FEC reports).

In response to the inquiry regarding the in-kind contribution on 5/19/08 from US Oncology PAC for \$650 of staff time, US Oncology has represented to ERIC PAC that \$650 corresponds with the usual and normal charge for US Oncology staff time that was devoted to an ERIC PAC fundraising event.


