2. On Line 5(d), your committee's qualification date has been omitted. Please be advised that a committee's qualification date is the last date on which the committee has met all the multicandidate certification requirements. Please file an amended Notification of Multicandidate Status (FEC Form 1M) to provide the committee's qualification date.

If the information you provided was incompletely or incorrectly disclosed or you believe the Commission records to be in error, please submit documentation which will clarify the matter. Should your committee meet the requirements for multicandidate status, please submit an amended Notification of Multicandidate Status (FEC FORM 1M) with the corrected information. 
