I filed Yeager v State of Alabama et al in the Ohio Northern US District Court in 2011, refiled in 2012, for ballot access, being burdened by State & Commonwealth Unconstitutional election code on Independents for said Federal Executive Office. My phones have been invaded since 2004. In 2004, I remitted a letter & brief to the U. S. Supreme Court Chief Justice Wm Rehnquist, who denied original jurisdiction for said brief (same cause), citing U. S. Amendment 11 as a bar. Currently, I have remitted a letter for the same U. S. Supreme Court original jurisdiction, answering the litmus test for said Amendment 11 bar to proceed, or call up said 2012 refiled brief & last opinion, which related I would have to file in the other 50 District courts, which is also burdening.
