Dear Ms. Wilkens:

I am writing as a follow-up to our telephone conference on Wednesday, July 12, 2000, regarding the above-referenced separate segregated fund (the "Fund"). As we discussed during that conversation, the Fund has not filed a report since October, 1998 -- an oversight that apparently resulted from the confusion surrounding the bankruptcy and restructuring of the Fund's connected organization (Zenith Electronics Corporation ("Zenith")), which took place in 1998 and 1999. For your reference, I have enclosed a document that describes these changes in greater depth. Attorneys for Zenith recently discovered that the Fund still exists, although it has been inactive since the time of the last report. Subsequently, Zenith contacted Winston & Strawn for assistance in terminating the Fund, prompting my telephone call to you.

During our conversation, you advised me that in order to terminate the Fund, the Federal Election Commission will require the Fund to file the following reports: 1998 Year End; 1999 Year End; April 2000 Quarterly; and July 2000 Quarterly, which will also serve as the Termination Report. Because the Treasurer currently designated for the Fund is no longer employed by Zenith, you and I also discussed the need for the Fund to file an Amended Statement of Organization, pursuant to which a new Treasurer would be authorized to sign these reports. Consistent with your directions, Zenith has completed these documents and will be sending them to your attention today (via certified mail) under separate cover. (For your convenience, a copy of this letter will be included in that mailing.) You further informed me during our conversation that if these documents were filed in this manner, the Fund will be deemed to have no outstanding reports as of the mailing date (July 14, 2000), and thus will not be subject to the administrative fine system for late filings that will go into effect on July 15, 2000.


