

Dear Sir:

In response to your letters to our committee, we have prepared amended FEC reports for the above noted reporting periods for the Lynn Woolsey for Congress Committee.

The beginning cash balance for the October Quarterly Report as indicated by our amended July Quarterly Report dated 9/30/94 was in error. In fact, beginning cash balance as indicated on our original July Quarterly Report and our amended September 16 report for this same period were correct.

However, during this period we incorrectly listed itemized contributions from Larry Tencer (pages 12 and 13) on our Schedule A of this report. In fact, these payments were refunds of an overpayment for an insurance policy for the campaign's office and equipment. We have corrected this refund and amended this report.

Similarly, we have corrected the Schedule D reports for this period as well as the 12 Day Pre-General Report. Pursuant to your letter to our campaign, we have included the omitted Schedule C from the 12 Day Pre General Report.

Please note that the payment to Will Stone from this Report (page 1, Schedule B) represents a partial repayment of the debt to Campbell, Falk & Selby (Schedule D). Mr. Stone was employed by
