Attached please find the January 31st year-end report for the '98 Friends of Chris Dodd campaign committee.

This report was not postmarked by midnight last night because I ran into a technical problem producing the final copy.

Since our principal campaign committee changed mid-calendar year, I could not run the report from my main database (the year-to-date figures would be wrong). In an attempt to get as much information on the report as possible, I entered employer and occupation information into the system yesterday, and then exported the relevant portion of the database yesterday evening to produce this year-end report.

I failed to properly execute the export and lost some of our contribution information and all of our computer records of expenditures for this reporting period. I have spent the entire night and morning, re-entering all the lost data from our backup information. Some of the employer/occupation information was obtained over the phone, so I will have to write and call those contributors again to regain the information. As soon as it is obtained, I will file appropriate paperwork to pass it along. I did not want to hold up this report any longer, and since it accurately reflects our receipts and
