Re: Managed Funds Association Political Action Committee Response to April 29, 2013 Letter

Dear Ms. Miller:

This letter is Managed Funds Association Political Action Committee's ("MFA PAC") response to the April 29, 2013 letter from the Federal Election Commission ("FEC") regarding MFA PAC's amended year-end report (11/27/2012 – 12/31/2012). As discussed on a May 1 phone call between you and MFA staff, MFA PAC made a \$4,000 contribution to Montanans for Tester on December 18, 2012, which was designated on the check as debt retirement for the 2012 general election. Enclosed with this letter is a copy of the check and the invitation for the event.

MFA PAC's amended year-end report inadvertently disclosed the \$4,000 contribution as being made for the general 2012 election, instead of for debt retirement. On May 7, MFA PAC submitted an amended report correcting this inadvertent error and disclosing that the contribution was for debt retirement for the 2012 general election. As discussed on the May 1 call, we have amended the report to disclose "debt retirement" on the line "Purpose of Disbursement" as well as in the text box beneath the amount of disbursement. We also have checked the box for general 2012, with a note beneath the checkbox indicating the disbursement was for "general debt 2012."

We believe the amended filing on May 7 is fully responsive to the April 29 letter and that no further action is required by MFA PAC with respect to this matter. If you have any questions regarding this matter, please do not hesitate to contact Benjamin Allensworth or me at (202) 730-2600.
