This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Schedule E supporting Line 24 of the Detailed Summary Page on your July Quarterly Report (4/1/2024 - 6/30/2024) discloses Schedule E entries for apparent independent expenditures publicly disseminated on behalf of "TRUMP, DONALD J." and designated for the "O2024, ANNUAL" Election. Your 48-Hour Report, received 9/29/2023 discloses the apparent estimated payment for these independent expenditures, but discloses them as designated for the 2024 General Election. Please amend your report to clarify this discrepancy and provide further information concerning these report(s). (11 CFR §104.4)

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
