Dear Mr Buckley,

Thank you for assisting me with FEC FORM 1 last Thursday. As you may have gathered from our conversation, we are a grass roots political party without much "hands on political experience". I appreciated your assistance very much.

Attached is an amended FEC FORM 1 which provides our e-mail address and we have changed the response to question 5. As you suggested regarding question 5, we have checked off (f) to designate the Political Action Committee activity that best describes us.


Almost all the Federal Election Campaign Laws sent to us so far relate to current campaigns and do not address political party development, which is the stage at which ATLP is at. Please advise whether there are any federal regulations that have been written more explicitly for our situation. ATLP needs to develop infrastructure to promote the party, so that we can eventually attract excellent candidates to run for state and federal office. Accordingly, our volunteers need office equipment such as computers and copy machines to publically explain our platform and develop a media campaign to promote our party. Rather than to just assume, we ask whether we can use funds from a federal PAC to build this infrastructure common to both state and federal political party activity and to use media advertising to announce our workshops and forums?

A second issue is that single individuals have given millions of dollars to fund political parties. For example, the Democratic Party is reported to have received \$9,000,000 from a person by the name of Saban. Ross Perot was apparently able to use his personal fortune to create the Reform Party. If true, we have not been able to find regulations on this type of donation and whether a new political designation such as ours can have a mechanism to raise funds other than with a state and federal PAC, which markedly restrict donations.

A third issue is the recent Supreme Court decision enabling superpacs. Could you direct us to the regulations the FEC has developed for superpacs?
