In our switch from using a software package to selecting a compliance vendor, we have changed the method we use to disclose our contributions from individuals. The following Schedule A supporting Line 11(a)(i) reflects this change. The Schedule also provides occupations for several contributors omitted from the original report. Please note that the PAC is aware that we now follow an alternate method of itemizing payroll receipts rather than one FEC-suggested manner of disclosing a single total for the reporting period along with the amount deducted per pay period. Because the amounts collected per pay period may change often during the time covered by a single report, we find that reporting individual deductions separately more accurately discloses how the receipts are collected. Additionally, the original report overstated itemized contributions due to the lump sum method of itemization on Line 11ai.
