Please be advised that itemized independent expenditures 24 and 48 Hour Reports disclose the disclosed on should following information: the name and mailing address of the payee, the purpose of the communication expenditure, the date the is publicly disseminated or distributed, the amount, the name and office sought, state and district (if applicable) of the federal candidate, the calendar year-to-date, per election, for office sought total, the election designation, an indication of whether the candidate was supported or opposed and the signature of the treasurer. Please amend the 48 Hour Report by providing the state. (11 CFR §104.4(b) and (c)) Please be advised that each State's Presidential primary is considered a separate election for purposes of aggregating independent expenditures. Advisory Opinion 2003-40.

The Commission notes the memo text attached to your report stating in full, "The independent expenditures reported represent national media/advertising purchases and are not related to a particular state primary election. The committee is reporting in accord with available public guidance from the Commission (Memo dated 9-30-15 - Draft Interpretive Rule on Reporting Nationwide Independent Expenditures in Presidential Primary Elections)."

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

<u>Electronic filers must file amendments (to include statements, designations and reports)</u> in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
