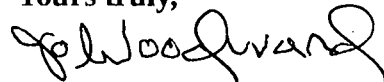
Greetings...Ms. Jackie Gausepohl: I have amended FORM 2 as ask by you/your office via first class mailed letter dated February 22, 2023.
