Dear Ms. Williamson:

This letter is in response to your request for additional information, dated June 30, 2000 and received by Friends of Bob Livingston PAC on July 5, 2000.

Friends of Bob Livingston PAC was previously a Candidate Committee, Friends of Bob Livingston. This Committee was established in 1976 or 1977, and has had at least 51 contributors. When the Committee changed from a Candidate Committee to a Political Action Committee on May 1, 2000, it had already made contributions to more than five federal candidates. I spoke directly with Lisa Stolaruk in the Reports Analysis Division, and she verified that the Friends of Bob Livingston PAC would immediately qualify as a multicandidate committee.

The Committee filed Form 1M on June 2, 2000 and listed contributions to five federal candidates, as required. However, you indicated that these contributions were made after the date that the Committee qualified as a multicandidate committee. Lisa Stolaruk advised me to include a list of previous contributions to federal candidates in this letter. They are:
