In response to the Federal Election Commission's ("FEC") notice to the Northern Trust Corporation Federal Political Action Committee (C00515148) dated April 12, 2015, we have taken the following actions:

- Due to a clerical oversight, the March 28, 2011 contribution of \$5,000 to Kirk for Senate was inadvertently reported as "General". The April 2011 Quarterly Report has been electronically amended to properly report the contribution as "Primary".
- Due to a clerical oversight, the February 7, 2013 contribution of \$1,000 to Roskham for Congress was inadvertently reported as "General". We have enclosed an amended April 2013 Quarterly Report which properly reports the contribution as "Primary".
- Due to a clerical oversight, the December 17, 2013 contributions of \$1,500 and \$2,500 to Roskham for Congress were inadvertently reported as "General". We have enclosed an amended Year-End 2013 Report which properly reports the contributions as "Primary".

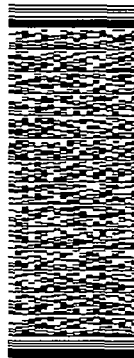
