This letter is prompted by the Commission's preliminary review of the report(s) referenced above. Please be advised that when amending information that affects entries on a report, you must amend the actual report to reflect any additions, changes or deletions. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.

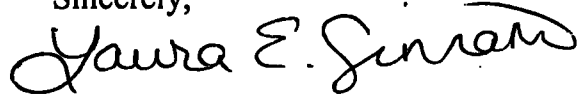

Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
