
TO WHOM IT MAY CONCERN:

You will note in this report that, for the 1998 election cycle, a number of participants in the Harris FEPAC program elected to designate earmarked contributions to candidates of their choice, with contributions made through payroll deduction. The earmarked contribution to the designated candidates is intended to be made within ten days after the specified amount of the contribution has been collected through payroll deduction.

Unfortunately, during 1997 and 1998, we experienced several personnel changes among those administering the program, including two changes in the Administrator. We also made a major change in the software that is an integral part of our program administration. As a result, we did not make the contributions within 10 days after the full amount earmarked for the candidate had been accumulated, but did make them in September, 1998.
