On or about December 7, 2010, I phoned you to discuss the adequacy of needed Paperwork to certify the Candidacy of R. Kenneth Jones for Presidency in the Election year 2012. Your comment was that needed Forms had been submitted and received and that they were in order. However, on the following day, I received a letter saying that I failed to adequate 11CRF102.2(a)(1),(vii) & (viii) end 11CRF§102.2(a) (v). 11CRF102.2(a)(i)(vii) & (viii) is not applicable, qua 11CRF102.3(v), (vii) & (viii). However, FEC Form 1 (revised 02/2009) was partially erroneous, Line "C" of category 5 should read R. Kenneth Jones. Line "D" of category 5 should designate the Committee as being National. Also, Line "D" of category 5 designates the Republican party as association of Political inclination.

Candidate Jones seeks the Office of President in the Election year 2012. Election day for that year is November 6, 2012. Chief Lane Alludes to candidacy for U.S. Senate. However, "Acknowledgement of eceipt of Statement of Organization" states explicitly that the Committee's goal is to elect R. Kenneth Jones President of the United States of America. Candidates for U.S. Senator and President have different Reporting requirements. The confusion is relative to these different designations.

In retrospect, these Amendments and Corrections should clarify intentions of Candidate and solve for present and becoming status. My hope is that the FEC isn't a circumlocution office and that analysis is relevant and practical.
