Dear Ms. Adame-Wilson:

This letter is provided in response to your correspondence of May 12, 2019, regarding Right Now USA's Amended 30 Day Post-General Report (10/18/2018 – 11/26/2018), received 02/12/2019, Identification Number C00658815. A copy of this letter is attached. We appreciate the opportunity to provide additional information in response to your preliminary review of this report. Below, we provide information you have requested about the following two items:

- Our amended report does not disclose a decrease in receipts totaling \$50,000. Review of the amended and original reports show the same amount of receipts, that amount being \$170,000. We do agree that the amended report shows a decrease in disbursements of \$50,037.96. Our original report had a disbursement to 1854 Inc. of \$56,700 that was in error. The correct amount was \$6662.04, which is reflected on the amended report. The difference between \$56,700 and \$6662.04 captures the decrease in disbursements of \$50,037.96.
- 2. On the 24-hour report, we had technical issues getting the Form 9 reports filed on 10/31/2018. Jeff Martin, our contract controller, reported on 10/30/2018 that he could not find Form 9 on the FEC software that had been downloaded for him. However, Martin then reported having submitted the filing on October 31st. See attached copy of email thread. When we did not see the Form 9 filings on the FEC portal, the Form 9 reports were sent manually to my office. Those reports were then filed again by my assistant on 11/01/2018. We have since changed our controller and updated our reporting capabilities.



This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in enforcement action. Additional information is needed for the following 2 item(s):

- 1. Your amended report discloses a decrease in receipts totaling \$50,000.00 and a decrease in disbursements totaling \$50,037.96 from the amounts disclosed on your original report. Please amend your report or provide an explanation to clarify why this additional activity was not provided with your amended report. (11 CFR § 104.3)
- 2. Schedule E of your report indicates that your committee may have failed to timely file one or more of the required 24 hour report(s) regarding "last minute" independent expenditures (see attached). A political committee must file a 24 hour report with the Federal Election Commission as specified in 11 CFR §104.4(c), within 24 hours of any independent expenditures of \$1,000 or more with respect to a given election, made between two and twenty days before an election. The report must be received by the Commission by 11:59 p.m. on the day following the date on which independent expenditures that aggregate \$1,000 or more are publicly distributed or disseminated. These expenditures must then be fully itemized on Schedule E, or as memo entries on Schedule E and reflected on Schedule D if distributed or disseminated prior to payment, of the next report required to be filed by the committee. Although the Commission may take further action concerning this matter, your prompt response will be taken into consideration. (11 CFR §104.3(b))

Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
