Dear Mr. Colburson,

The following is a Form 99. This Form 99 relates to the Form 3 Termination Report covering the period of 7/1/2008 through 6/30/2012 filed by the Kobach for Congress committee.

Overview:

In August of 2009, Mr. Kris Kobach requested that I review the reports filed with the Federal Election Commission (FEC) by his 2004, Kobach for Congress campaign. At that time it was evident that the reports were inconsistent with the bank account balances; and the former Finance Director of the campaign, Mr. Christian Morgan, was unresponsive to requests to assist in reconciling the account. Additionally, the bank at which the campaign accounts were located went out of business and now no longer has the records needed to conduct a proper reconciliation. Mr. Kobach requested that I complete an audit of the campaign accounts and file any unreported contributions and expenditures that I may discover and perform all other acts necessary to close this campaign account.

My review of campaign documents, campaign bank statements and the reports filed with your agency reveal that the last FEC report filed by the Kobach campaign was for the period ending June 30, 2008. While this campaign account was operational, the day-to-day maintenance and recordkeeping was performed by Christian Morgan; therefore, I was able to examine the account from an independent perspective. There was very little activity in the last four years the account was in existence. In May 2009, Mr. Kobach disbursed all of the campaign funds remaining in the campaign checking account and closed the campaign checking account. Subsequently, Security Savings Bank failed; and on October 15, 2010, the former Security Savings Bank's deposits were transferred to Simmons First National Bank. Please see attached letter from Simmons First National Bank.

Available Resources for Reconciliation:

In addition to the reports filed with the FEC, the resources available to reconcile the FEC reports were limited to copies of bank statements from three accounts at Security Savings Bank. Kansas statutes concerning record retention require a bank to keep records for five years. Therefore, during my audit of these records in 2010 and 2011, only copies of canceled checks for 2005 and forward were available to

me. Multiple attempts have been made to contact the former finance director of the Kobach for Congress campaign, Christian Morgan, to determine whether additional records from the campaign exist. Mr. Morgan has not responded to those requests. Any records that may be in Mr. Morgan's possession have remained unavailable to me. The sole original financial document from the campaign discovered during my review is a checkbook register. The oldest transaction recorded in this checkbook register is dated January 19, 2005. The bank statement is a limited resource because it only reports each transaction by its amount, date, and whether it is a debit or credit. During the time of the campaign, Security Savings Bank was not in the practice of including copies of canceled checks or deposit slips as part of the bank statement.

Steps Taken to Reconcile the FEC Reports:

I created a spreadsheet listing each Form 3: Report of Receipts and Disbursements (Form 3) filed with the FEC by this campaign. For each Form 3 I included the beginning balance, the total contributions, the total expenditures and the ending balance. Then on the same row, I entered the sum of each bank statement corresponding to the time period represented on each Form 3 report. I included the credits, debits and ending balance from each bank statement. I excluded all transfers between the three bank accounts. I also excluded all reported "in-kind" contributions and expenditures.

Through this process I found that total contributions reported to the FEC equals \$1,272,516.08. The bank statements report a total of all credits of \$1,302,402.01. This represents a difference of \$29,885.93. See endnote 1. The total of all expenditures reported to the FEC equals \$1,195,526.99. The total of all of the debits from the bank statements is \$1,302,402.01. This represents a difference of \$106,875.02. The net difference is \$76,989.09. This net figure is only \$158.88 less than the last reported ending balance as reflected on the 2008 July Quarterly Form 3 FEC report.

I also entered every transaction from the bank statements into a Quicken software checkbook register. The bank statements only report each transaction's amount, date, check number (if applicable), type of transaction (i.e. check or debit transfer), deposit, or transfer to another account owned by the campaign. I then looked at each itemized expenditure that was reported on each Form 3 and matched it to a transaction in the Quicken checkbook register with the same amount and as close as possible to the same date. There are instances where I assumed a reasonable period of time passed between the dates of the reported transaction and when the transaction cleared the bank. However, there are several transactions (in the Quicken checkbook) with a value equal to or over \$1,000 that I was not able to match up. See endnote 2. The nature and time of the expenditures indicates strongly that they were for radio and television media buys; but contact with the likely media vendors could not establish this conclusively because they too lacked the records necessary to confirm those 2004 media buys. See also endnote 3.

Also, several campaign vendors were asked to provide me a list of their invoices to the campaign. Through this process, I discovered six vendor expenditures that were erroneous (from that reported on the Form 3 reports). See endnotes 4 and 5.

At this point, I believe that the campaign and I have worked diligently to do everything possible to address any issues in the reports. However, the fact that the bank and the relevant records no longer

exist, combined with the unresponsiveness of the former campaign finance director, have made further corrections impossible to achieve.

I would be pleased to discuss the issues raised by this correspondence with you and to assist you to resolve any outstanding matters that must be addressed to close this campaign account. Please feel free to contact me by using the contact information enclosed with this letter.

Endnotes:

1. Reference to Page 6, Schedule A for Line 15, Transaction ID: SA15.4145:

"\$27,317.24 Aggregate of unreported assumed contributions from 7/1/2003 to 6/30/2008."

This number is derived from the total of all bank credits less the total of all reported contributions. Due to the limited resources available, it cannot be determined conclusively and therefore it is assumed that this represents contributions to the campaign.

2. Reference to Page 10, Schedule B for Line 21, Transaction ID: SB21.4144:

"\$49,099.48 Aggregate of unidentified itemized expenditures from 4/7/2004 to 2/14/2005."

3. Reference to Page 9, Schedule B for Line 21, Transaction ID: SB21.4118:

"\$565.93 Aggregate of unreported unitemized expenditures from 10/29/2003 to 1/11/2005."

4. Reference to Page 12, Schedule B for Line 21, Transaction ID: SB21.4124:

"\$4,520.00 National Research, Inc. Actual date is 10/15/2004. Benchmark poll."
