This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 3 item(s):

1. Schedule B supporting Line 23 of the Detailed Summary Page discloses contributions to "Defend Our Conservative Senate PAC," "GREATER TOMORROW POLITICAL ACTION COMMITTEE," "Razor PAC," "Turquoise PAC," and "VELVET HAMMER PAC"; however, you have also disclosed "Marshall, Roger Sen.," "Thompson, Glenn Rep. Jr.," "Womack, Steve Rep.," "Lujan, Ben Ray Sen. Jr.," and "Smith, Tina Sen." for these transactions respectively. Please clarify whether these were earmarked contributions made by your committee through the referenced committees to the respective candidates, or if you made the contribution to the political committee exercising no direction or control over how the funds were to be used. If the latter is the case, please do not include the candidate's name on your report. Please amend your report to clarify the ultimate recipient of this contribution(s). (11 CFR §104.3 (b)(3))
2. Your report disclosed a category of financial activity that has been reflected on the wrong line of the Detailed Summary Page. Contributions to federal candidates and other political committees should be properly disclosed on a separate Schedule B, supporting Line 23 of the Detailed Summary Page. Please refer to the instructions for each line when determining the proper categorization(s) for your filings. (52 U.S.C. §30104(b) and FORM 3X Instructions) Further, please amend your report to disclose these contributions

3. On Schedule B, you have disclosed disbursements to a federal candidate committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
