This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

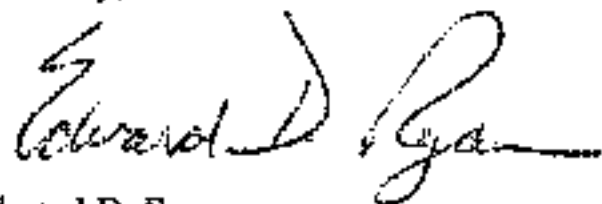

Although the Commission may take further legal action concerning the excessive contribution(s), your prompt action in obtaining a refund or redesignating the contribution(s) will be taken into consideration.
