Attached please find a Statement of Organization for a new separate segregated fund, the Washington Mutual, Inc. Home Loans Political Action Committee. The connected organization for this committee is Washington Mutual, Inc. The Committee has two affiliated committees: the Washington Mutual, Inc. Political Action Committee (FEC #C00129833) and the Washington Mutual, Inc. Finance Political Action Committee (FEC #C00347807).

The Washington Mutual, Inc. Home Loans PAC has previously existed as a state committee in the state of South Carolina. Originally, the Committee was connected to a corporate organization that was acquired by Washington Mutual, Inc. on June 1, 2001. The Washington Mutual, Inc. Home Loans PAC has a balance of \$18,359.00 as of 07/13/01. This balance reflects contributions made into the South Carolina state PAC. All contributions were made by the connected organization's restricted class and in accordance with the restrictions and limits mandated by the Federal Election Campaign Act of 1971, as amended.

Our attorney, Michael Nemeroff, contacted Colleen Manning of your office regarding this PAC and was informed that we will not need to report the source of the PAC's contributions on Schedule A until the 2001 Year End 3X Report is due. At that time, we will report the contributions made into the state PAC and carried over to the new federal PAC with memo entries on Schedule A.
