This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Schedule A supporting Line 17 of the Detailed Summary Page discloses a receipt for "Balance Adjustment to bring COH inline with bank. See Memo Text" for \$4,785.25. In memo text you state, "This report includes a balance adjustment of 4785.25 to fix a discrepancy between bank running balance and reported COH. After previous amendments, the discrepancy has been consistent since 1/1/2022. There were unreported operating expenditures (Paragon Payment Solutions) in 2nd half of 2021. The remaining \$5000 is likely from uncleared check(s) from between 1992 and 2020 that were not reported as voided." Please provide any clarifying information as to the details of this receipt and why this activity was not disclosed on the original report covering the period during which it took place.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
