These events have provided a very useful format for a small number of industry representatives to spend several hours with Members of the House and Senate. The "cattle call" fund-raisers are unable to provide us with a forum where we can create a higher profile for our companies and our industry. AFSA member CEOs and state lobbyists from the member's district or state are urged to attend.

In addition to serving on the Committee on Banking where he chairs the Subcommittee on Domestic and International Monetary Policy, Spencer is now on the Committee on the Judiciary and serves on the Subcommittee on Commercial and Administrative Law.

During his tenure on the Banking Committee, Spencer has taken a market oriented approach to issues facing the financial services industry, regardless of the political consequences. He is an experienced trial lawyer and a tough questioner who will make a great contribution to the Committee on the Judiciary. Spencer is backed up by superb staff and this is a good opportunity to get to know them as well.
