This report is being amended to update the YTD totals on lines 8 and 21(b) after correcting a clerical error on the October monthly report. All disbursements for NEGOP FUNDRAISING EVENT EXPENSE, NEGOP FUNDRAISING MAIL POSTAGE, and NEGOP FUNDRAISING MAIL EXPENSE were for fundraising purposes for the state party only; no federal candidate or federal officeholder was identified in any of these events. All disbursements and expenditures for FEA EXEMPT/BROCHURES and FEA EXEMPT/SLATE CARDS were for exempt party activity driven by volunteer efforts and meet the conditions of exempt party activity as defined by 11 CFR 100.87. All disbursements for FEA GOTV - GENERIC were for general party GOTV efforts. Non-federal funds were not used in connection with any federal election or federal election activity. Disbursements for employees who spend less than 25% of their time on Federal-election related activities are allocated as administrative expense. No payments are listed for rent as the Party owns the building from which it operates and therefore has no rent payments.
