This notice is prompted by the Commission's preliminary review of the report referenced above. 1. The totals listed on Line(s) 6(a), 6(c), 7(a), 7(c), 11(a)(i), 11(a)(ii), 11(a)(iii), 11(e), 16, 17 and 22, Column B of the Summary/Detailed Summary Page(s) appear to be incorrect. Column B figures for the Summary and Detailed Summary Pages should equal the sum of the Column B figures on your previous report and the Column A figures on this report. Please file an amendment to your report to correct the Column B discrepancies for this report and all subsequent report(s) which may be affected by this correction. Note that Column B should reflect only the election cycle-to-date totals (11/6/2024 through 11/3/2026). (52 U.S.C. § 30104(b) and 11 CFR § 104.3)
2. Schedule D of your report itemizes debt owed to "Geodriven LLC" with an outstanding beginning balance. This debt was not included on your previous report. Please file an amendment to your report(s) to correct this discrepancy. (11 CFR § 104.11(b))

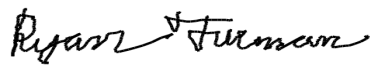
