Dear Sire:

Enclosed for filing please find an amended Statement of Organization (Form 1) and Notification of Multicandidate Status (Form 1M) for the above-referenced political committee. effect of this amendment will be to convert the Lynn Martin for Senate Committee, a principal campaign committee, into a nonconnected multicandidate political committee to be known as the New American Century Fund, Inc.

The Federal Election Campaign Act of 1971, as amended, defines a multicandidate political committee as a committee which (1) has been registered with the Commission for at least 6 months, (2) has received contributions from more than 50 persons, and (3) has made contributions to 5 or more Federal candidates. 2 U.S.C. § 441a(a)(4) and 11 C.F.R. § 100.5(e)(5).

The Commission has long recognized that a principal campaign committee may convert to a multicandidate political committee by amending its Statement of Organization to redesignate itself as a nonconnected political committee. See Advisory Opinions 1990-16, 1988-41, 1987-11, 1985-30, 1983-14, 1982-32 and 1978-86.

Moreover, in authorizing the conversion of a principal campaign committee into a nonconnected multicandidate political committee, the Commission has repeatedly stated that the transformed committee may avail itself of the period of registration of the principal campaign committee as well as the number of contributions received and made by the principal campaign committee. See Advisory Opinions 1990-16, 1985-30, 1982-32, 1980-40 and 1978-86.

The Lynn Martin for Senate Committee filed its initial Statement of Organization with the Commission on July 18, 1989. As reflected on the attached Form 1M, the Committee has since received contributions from more than 50 persons and has made
