Contribution to Bruning for Senate dated February 28, 2011

The MidAmerican Energy Executive PAC requests that its \$5,000.00 contribution to Bruning for Senate, dated February 28, 2011, be corrected to reflect a contribution to the General election, rather than to the Primary election, as previously reported. We had previously sought a refund from Bruning for Senate, but have since determined instead that the contribution was to be noted as a General election contribution.

With respect to our prior effort to seek a refund, enclosed is a copy of a letter sent October 17, 2011, by the MidAmerican Energy Company Executive PAC, requesting from the Bruning campaign a refund of the \$5,000.00 contribution to Bruning for Senate, which had originally been reported as pertaining to the Primary Election. Prior to this contribution in question and during the exploratory period of the campaign, a separate contribution of \$5,000.00 had been made by an affiliated PAC, the PacifiCorp/MidAmerican Political Action Committee (C00082800), with that separate contribution also designated for the Primary Election. The second contribution was made from the MidAmerican Energy Company Executive Political Action Committee (C00324483) to Bruning for Senate on February 28, 2011. Both contributions were originally designated for the Primary election. The Primary election designation for the second contribution was in error, as it exceeded the per-election limit on contributions from affiliated PACs. To correct this matter, the MidAmerican Energy Company Executive PAC is not seeking a refund, but will promptly file an amended FEC report for the 2011 mid-year period to properly report the election designation as General.
