

II. ACTIVITIES TO BE UNDERTAKEN

Philadelphia 2016 Host Committee, a Pennsylvania non-profit corporation, acting as a Host Committee pursuant to 11 C.F.R. §9008.50(b), will:

- (a) Defray the expenses incurred in the promotion of the Philadelphia metropolitan area for the 2016 Democratic National Convention (the "Convention");
- (b) Welcome Convention attendees to the Philadelphia area by sponsoring information booths, receptions, tours and other similar events and facilities;
- (c) Defray expenses incurred in facilitating commerce, such as providing Convention attendees with guides to the Philadelphia area and distributing samples and promotional materials;
- (d) Defray administrative expenses incurred by the Host Committee organization itself, such as salaries, rent, travel and insurance;
- (e) Provide and defray the costs of a comprehensive insurance program for the Convention;
- (f) Provide the 2016 Democratic National Convention Committee ("DNCC") with the use of the Wells Fargo Center and adjacent

facilities and areas for the Convention proceedings and related purposes, and use of the Pennsylvania Convention Center for certain other purposes; and provide construction and convention related services for and in the Wells Fargo Center including such items as are set forth in 11 C.F.R. §9008.52(b)(5);

- (g) Provide other Convention related facilities and services for the use of the DNCC including office space, facilities, equipment and supplies; communications devices and services; technology including hardware and software components of local and wide area computer networks;
- (h) Defray the costs of local transportation services, including the provision of buses and automobiles and use by Convention attendees of public transportation systems; and
- (i) Provide other similar Convention-related facilities and services.
