I am in receipt of letters from the FEC addressed to "Friends of Larry Pressler" dated 18Nov14 (from Kristen Roser), 18Nov14 (from Tyler Culberson), 19Dec14 (from Denorah Chacona, 24Feb15 (from Deborah Chacona), 5Jan15 (from Kristen Roser), and 5Jan15 (from Laura Sinram).

Let me begin by apologizing for not seeing these letters sooner. They went to my office, and were misrouted. If there are any I have not seen, please advise.

As a follow up to my call with Ms. Sinram, I understand that I managed to incorrectly file for two different committees under the name of "Former Staffers of Larry Pressler.". One of those apparently was registered under form 3X and is listed as C00570028, and the other was filed under Form 5 as C90015199. It is my understanding that I filed for m 3X in error, and that all the activity for "Former Staffers of Larry Pressler was disclosed on Form 5 (C90015199). "Former Staffers of Larry Pressler" (both C00570028 and C90015199) does not plan on being active any further, and was intended to be closed down in all respects. Please take whatever actions necessary to close them down. This was a one-time ad and expenditure we developed on our own, on behalf of our former boss, Larry Pressler, who lost the election and does not plan to run again.

I will contact Brad (202.694.1166) to confirm that there is no further action necessary with respect to the Form 5 committee. But I would like to make clear that this was a one-time ad involving expenditures which were incurred and paid for on the same day or week, and will not be repeated. So to the extent there is anything further to close down this matter with finality, please let me know.
