The Committee is in receipt of the Commissions Request for Additional Information dated January 6, 2011 regarding 48-hour notices. 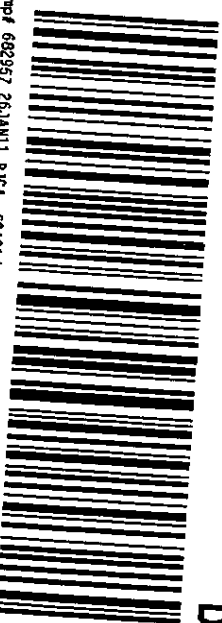

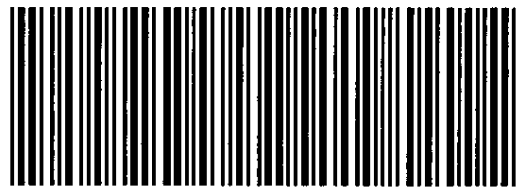
