I registered in the State of Oklahoma as a Candidate for Congress, however, I did not spend or raise funds over \$5,000 until November 2nd. In my campaign, I accepted no financial contributions from anyone. I had no staff, no treasurer, or campaign manager. I was running to raise visibility.

Newspaper reports ten days before the election reported the undecided vote was larger than what elected the previous incumbent, so I decided to increase my visibility on November 2nd by running radio ads, and a few extra newspaper ads.


Per the FEC rules outlined in the FEC campaign guide, I became a Candidate on November 2nd 2000, when I made contributions over \$5,000.00 to my campaign, out of my pocket.

Seven days later, November 9th, I designated a campaign committee, "Neil Mavis 2000 committee". This is within the 15 day requirement stated in the FEC campaign guide, page 5.
