Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following 5 items:

- 1. The beginning cash balance of this report should equal the ending balance of your Amended 2009 Year End Report, received 5/20/10. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
- 2. Schedule B supporting Line 21(b) of your report discloses \$8,143.03 in activity identified as MEMO entries that do not appear to correspond with any itemized transaction(s). Please be advised, a memo entry is used to disclose additional information about an itemized transaction and the amount of a memo entry is not included in the total receipts or Please amend your report to provide disbursements for the report. clarifying information regarding this activity.
- 3. Schedule B supporting Line 21(b) of your report discloses totals of \$18,128.02 in payments made to apparent credit card companies; however, the sum of the memo entries provided identifying the original vendors associated with these payments total \$22,903.34. Please amend your report to clarify this apparent discrepancy.
- 4. Your report disclosed a category of financial activity that has been reflected on the wrong line of the Detailed Summary Page. Contributions

from other political contributions and other federal operating expenditures should be properly disclosed on a separate Schedule A and B, supporting Lines 11(c) and 21(b) of the Detailed Summary Page, respectively. Please refer to the instructions for each line when determining the proper categorization(s) for your next filing.

5. Please clarify all expenditures made for ": fundraising services," "Administrative/Salary/Overhead: catering," "Fundraising: catering," "Fundraising: fundraising services" and "Fundraising: venue fee" on Schedule B. If a portion or all of these expenditures were made on behalf of specifically identified federal candidates, this amount should be disclosed on Schedules B or E supporting Lines 23 or 24 and include the amount, name, address and office sought by each candidate. 11 CFR §§104.3(b) and 106.1

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
