Thank you for filing the Statement of Organization and the 2013 October Quarterly Report for Bergmann for Congress with the Federal Election Commission (FEC). Please call us at your earliest convenience to discuss these filings, as they would need to be re-submitted without the FEC ID number of Ms. Bergmann's previously terminated committee.

Since Bergmann for Congress (C00512194) was terminated in April 2013, you need to establish a new committee, which would be assigned a new FEC ID number, and re-submit the filings so that they can be indexed under the new ID number. (A terminated committee cannot be reactivated.) To establish a new committee, please file a Statement of Organization (FEC Form 1) as soon as possible, leaving the ID number field blank. A new ID number will be assigned by the FEC.
