The fundraising component never developed under Ms. Simon; instead, focus was placed upon consensus building. The \$5,000.00 threshold has not been met, solely, because the effort of this campaign has not been initiated; however, the fundraising aspect of the campaign is now underway with the change from Simon to Smith.

Although candidacy is certain, the financial threshold has not been crossed; yet, this will take place within the weeks upcoming, therefore, the required financial disclosure forms will be sent to the FEC, once this occurs.
