This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

All contributions from a single individual, regardless of the number of different dealerships, should be aggregated together towards the individual's aggregate year-to-date total (see attached). Further, contributions received aggregating over \$200 per individual for the calendar year should be reported on Line 11(a)(i) and itemized on Schedule A.

-Your report(s) was not signed by the treasurer or designated agent listed on your Statement of Organization. Please amend your report(s) by providing the signature of an individual that is authorized to sign the report(s). 2 U.S.C. §434(a)(1) and 11 CFR §104.14(a) and (d)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal
