This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule B of your report (pertinent portion(s) attached) discloses a contribution(s) which appears to exceed the limits set forth in the Act. 2 U.S.C. §441a(a) precludes a multicandidate committee and its affiliates from making a contribution to a candidate for federal office in excess of \$5,000 per election.

If the contribution(s) in question was incompletely or incorrectly disclosed, you should amend your original report with clarifying information. If you have made an excessive contribution, you should notify the recipient and request a refund of the amount in excess of \$5,000 and/or notify the recipient in writing of your redesignation of the contribution. In the best interest of your committee, all refunds and redesignations should be made within sixty days of the treasurer's receipt of the contribution(s).

Please inform the Commission of your corrective action immediately in writing and provide a photocopy of the refund request sent to the recipient committee(s). In addition, any refunds should be disclosed on Schedule A supporting Line 16 of the report covering the period during which they are received. Any redesignations should be disclosed as memo entries on Schedule B supporting Line 23 of the report covering the period during which the redesignation is made. 11 CFR §110.1(b)

Although the Commission may take further legal action regarding the excessive contribution(s), your prompt action in obtaining a refund and/or redesignating the contribution(s) will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Dear Ms. Johnson:

This letter is in response to your inquiry dated March 11, 1997 regarding the appearance of a contribution from the Lockheed Martin Employees' Political Action Committee (LMEPAC) which exceeded the maximum allowable limits.

Upon review of the contribution history and other relevant data, our records indicate that while there were indeed errors made with respect incorrectly disclosed designations, LMEPAC filed amendments with the Federal Election Commission dated July 25, 1997 correcting these errors.

The history of contributions and designations is as follows:

- On March 13, 1995 a contribution to the Judd Gregg Committee was made in the amount of \$1,000. On June 29, 1995 another contribution was made to the Gregg Committee also for \$1,000. Both of the contributions were incorrectly disclosed as General. DC
- On May 21, 1997 two contributions were made. The first contribution in the amount of \$3,000 was designated Primary and the second contribution in the amount of \$2,000 was designated General. DC
- In July of 1997, we became aware of the designations of contributions from 1995 which were incorrectly disclosed. LMEPAC filed the appropriate amendments with the Federal Election Commission on July 28, 1997. Copies of the filed amendments are enclosed.
- The final contribution made to the Gregg Committee occurred on November 11, 1997. This contribution was for \$3,000 and was designated General.
