- Dennis DeConcini made a contribution to our PAC as a private citizen after he left the United States Senate. He requested a refund from the PAC so that he would not exceed his personal contribution limit.
- 2. The multicandidate form was filed improperly and has been re-filed. The date of qualification is October 21, 1998, not 1997. The post election report will show that all requirements were met as of October 21.
