
Dear Ms. Sugarman:

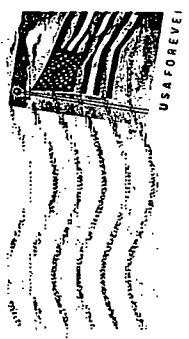

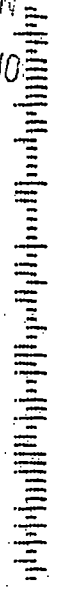
