Dear Ms. Sagri:

Thank you for the information given to us during our telephone conversation of May 11<sup>th</sup> and also on May 31<sup>st</sup>. Because of those conversations, our discussions, and a review of the Campaign Guide for Non-Connected Committees, we were able to better understand the procedures that should be followed in completing the scheduled reports.

Since we are a Non-connected Committee as described on Page 3, Chapter 1 of the Federal Election Commission Campaign Guide (Feb. 2002), we believe that all expenditures reported on Schedule B listed in your letter and the two reported on Schedule B of the 1/31/05 Report are really Independent Expenditures as described in Chapter 9, Pages 40 (line 24), 42 (line 7), and 72 (Independent Expenditure)

Our expenditures were not made with the cooperation or prior consent of, or in consultation with or at the request or suggestion of, any candidate or authorized committee or agent of a candidate. Listing John Kerry on Schedule B is clearly misleading and should not have been used. The six advertisements used for these expenditures clearly state that they were not authorized by any candidate or candidate's committee.

In order to be sure that we follow correct procedures, we have amended the last three reports and also included the Last Minute Independent Expenditure Report. This report should have been mailed to you 24 hours after 10/27/05.

We thank you for the kind attention that you have given to our problem and apologize for taking up so much of your time.
