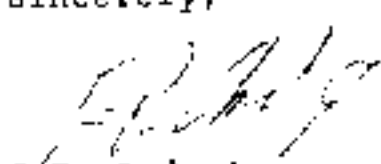
Dear Ms. Stasiek:

(See Attached) It is again itemized on Schedule A for Line 16, Refunds of Contributions Made to Federal Candidates. Please be aware that this error also affects Column A and B totals for Lines 6(c), 11(a)(i), 11(a)(iii), 11(d), 19 and 20. Please amend your report to correct these discrepancies.
