I sincerely apologize for the long delay in turning in my 2001 mid-year report and amendments previously requested by the FEC for the Tony Samuel for Congress Committee (C00349605). Included is the 2001 mid-year report and amendments to all of the previously filed FEC reports for my campaign. Again, I regret that I have failed to file this report and the amendments in a much more timely fashion, but I would like to offer a brief explanation.

I was aware of several minor mistakes in our previous reporting and from time to time began to fix the problems. However, it seems that my work or some other crisis would always get in the way and I would end up putting the reports to the side. I should have been much more responsible than this.


As for the 2001 mid-year report, the problems were two-fold. First of all, I knew that I couldn't accurately file the report without first amending the previous reports. I have been working two and sometimes three part time jobs this year as I was awaiting a position with the Bush Administration in Washington. I believe I mentioned this to you in a discussion a few months ago. Since that time, the position with the Administration fell through and I have had to struggle to make ends meet and pay off my large campaign debt. This left me with little time to work on our reports.

Secondly, I had been considering running for the office in the future, keeping the campaign open, and eventually paying myself back from the campaign for what I had attempted to report as candidate loans to the campaign. However, I have decided not to pursue the office at any time in the near future and would like what I previously attempted to report as loans by the candidate to now be considered contributions by the candidate. The amendments and mid-year report reflect this change.

I now have a new job as Press Secretary for the Republican Caucus in the Indiana House of Representatives, and over the last few weeks have been able to settle down and finally work on these reports. Finally, I have just payed off my debt to the IRS and will be paying off my final debt to Streetwise Promotions this Monday, December 31, so that all campaign activities will be concluded in 2001 in order to file a report to terminate the campaign committee with the January end-of-year filing.
